Purpose

The purpose of this position as Coordinator Autism and Mental Health Services Project is to achieve positive outcomes for autistic people by building the capacity of mental health professionals to better understand and support autistic people effectively.

Responsibilities

- Coordinate the development and delivery of autism-specific training for mainstream community mental health professionals
- Develop and deliver workshops to enhance the confidence, knowledge and skills of mainstream community mental health professionals
- Provide leadership, development, support and effective performance management of all direct reports
- Collaborate with Queensland Primary Health Networks (PHNs) to assist in mapping community mental health services to enable dissemination of information and training to health professionals in these services
- Maintain accurate data and records and provide timely and informative reports, in alignment with funding body contracts including key milestones and performance indicators.
- Monitor the project budget and report on financial performance

Key Performance Indicators (KPIs)

- Reports and input for service delivery, submissions and performance reports are provided as required and on time.
- Services are developed, costed, scheduled and delivered to meet funding body requirements and within budget.
